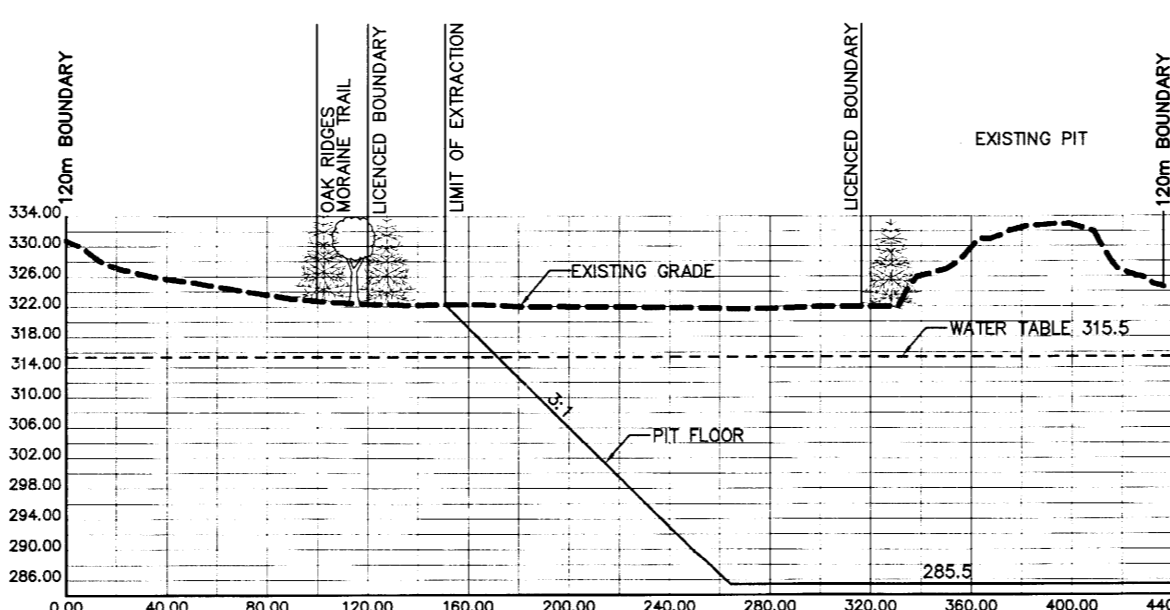

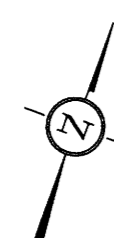
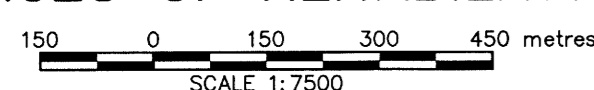


SECTION C-C'

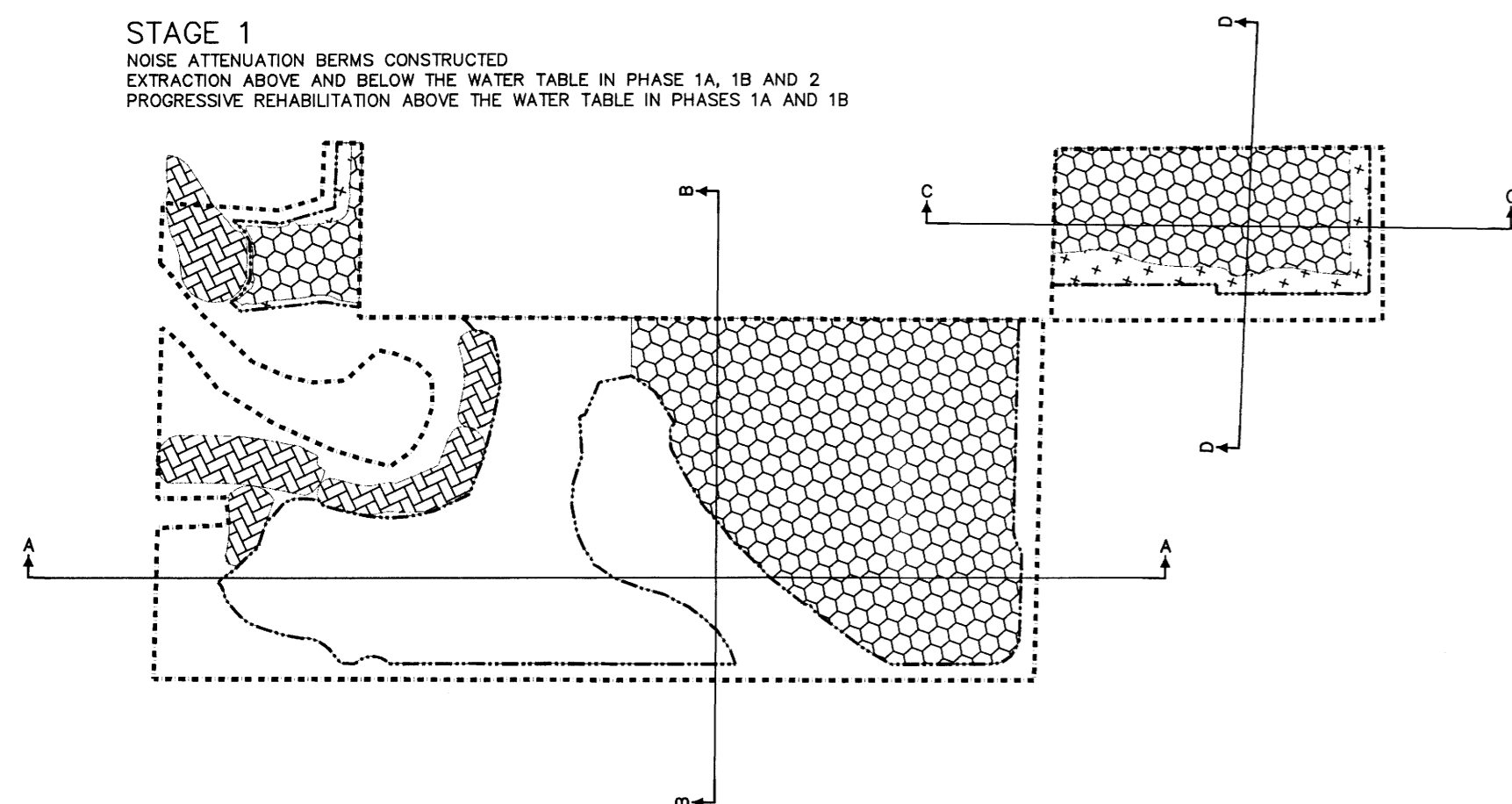

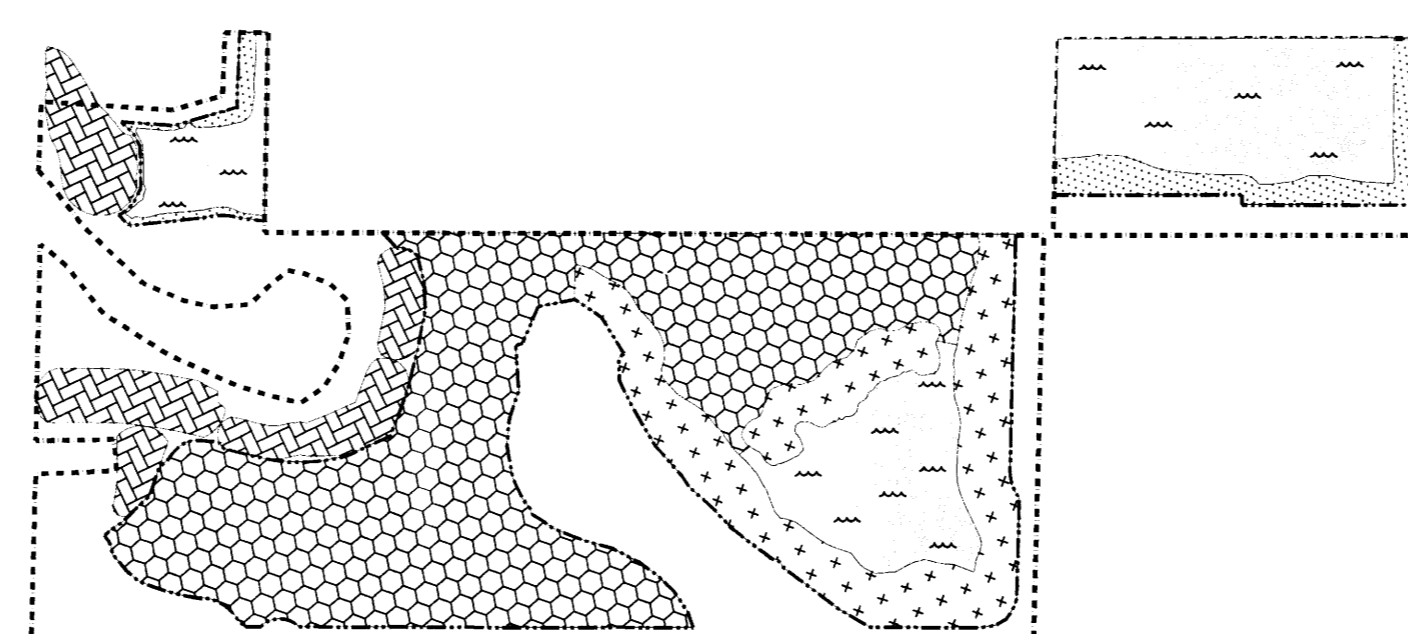

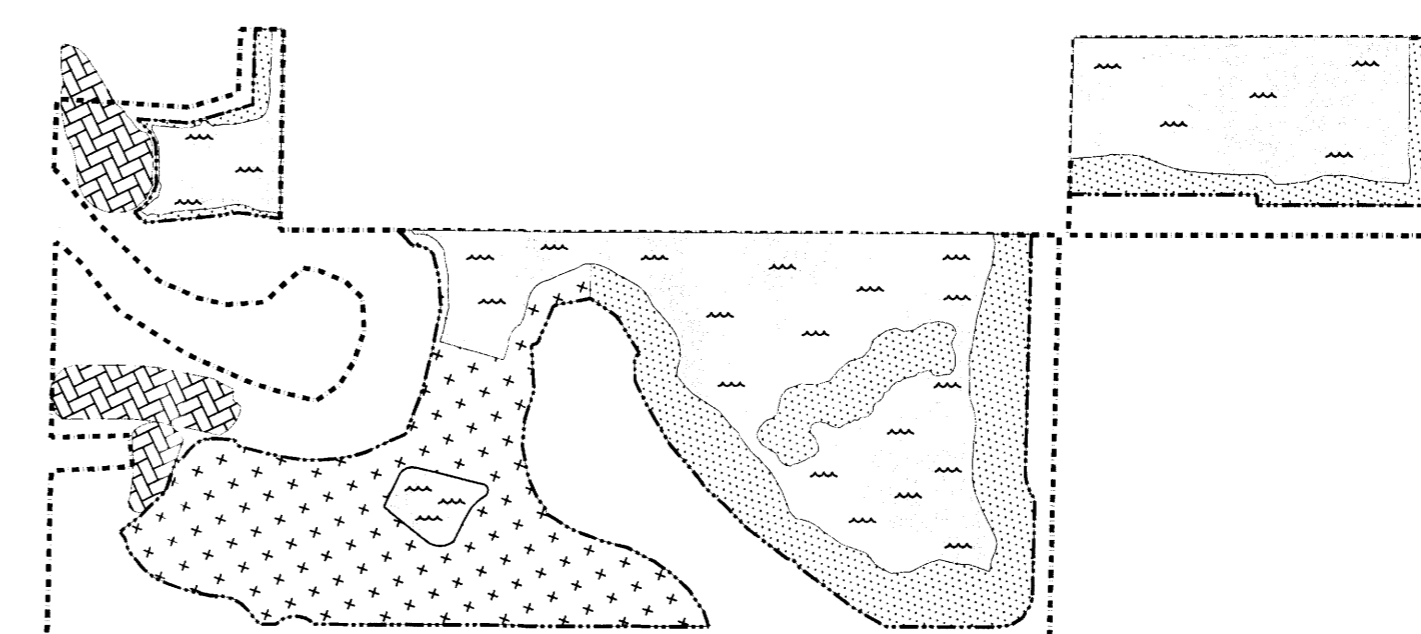
STAGE 1
